# **Championship Rugs**

Championship Rugs will be presented using the championship point score system 3.19.i) or as detailed below for the CDIU25 & CDIY.

- Horse & Pony Champions Novice to Advanced
- Small Tour Champion (horses) (Prix St Georges & Intermediate I)
- Medium Tour Champion (horses) (Intermediate A & Intermediate B)
- Grand Prix Champion, points shall be allocated to the CDIW Grand Prix and CDIW Freestyle.
- An Overall FEI Pony Champion will be determined by championships points (e.g. Prix St Georges & Inter I; Intermediate A & B; or Intermediate II / Grand Prix).
- Winner of the CDIY Freestyle
- Winner of the CDIU25 Grand Prix Freestyle

# **Special National Awards and Trophies**

- The Dietmar Specht Memorial Trophy: This perpetual trophy donated by the Horse Magazine is designed to encourage talented young dressage riders. Riders must be under 30 years of age on the first day of the National Championships. The winner is chosen from the best two placings of the nominated combination in official competitions from Elementary to Grand Prix including Freestyles and G.P. Special. The winner will hold the Perpetual trophy for one year and will receive a mounted photograph from the Horse Magazine. Riders are to nominate on the entry form if they wish to nominate for this award. No entry fee is required. A rider may enter one horse only. In the case of equality, the horse with the highest aggregate (percentage) score is the winner.
- The Rod Barker Memorial Trophy: Presented by the Horse Magazine for the highest percentage score gained during the Australian Dressage Championships excluding freestyles.
- The Crown Law Memorial Trophy: Presented by Mrs Erica Taylor to the winner of the Grand Prix Special.

# **Details of competitions**

**EA Competitions Novice to Advanced:** A maximum of 35 qualified combinations per competition (35 horses) will be accepted. Champions to be decided on point system of both competitions at each level. Refer Rule 10.10 EA Dressage Rule Book.

Competitions Prix St Georges through to Grand Prix: A maximum of 35 qualified combinations per competition (35 horses) will be accepted.

**Grand Prix Special:** limited to a maximum of 15 combinations that gain at least 60% in the Grand Prix (rule 4.8.3 g. Entry fees will be refunded to the combinations that enter and do not qualify.

# **Freestyles**

**Advanced Freestyle:** Open to 15 combinations who have qualified in the Advanced competitions (based on championship point score system). Combinations must receive a minimum score of 60% in either of the qualifying advanced competitions.

**Intermediate I Freestyle:** Participation will be determined by performances gained in the Intermediate I Championship and combinations must receive a minimum score of 60% in the Intermediate I as per rule 4.8.3 f.

**Intermediate A/B Freestyle:** The number of entries will be limited to a maximum of 8. Participation will be determined by performances gained in the Inter A/B Championship and combinations must receive a minimum score of 60% in the Intermediate A or B as per rule 4.8.3 h).

**CDN Grand Prix Freestyle**: Combinations must receive a minimum score of 60% in the CDN Grand Prix to qualify for the Freestyle. The number of entries will be limited to a maximum of 15 horses. Consideration will be given to allow horses that do not qualify in the top fifteen for the CDIW Freestyle to compete in the CDN freestyle if space is available.

- Refer section 8 of the EA Dressage rules for further advice in preparing freestyles.
- The format and procedure for supplying music will be notified after the close of entries. Music must be provided one week before the start of the event.
- Refunds will be issued for riders that enter and don't qualify in the relevant qualifying competitions for the Freestyles.

#### **CONDITIONS OF ENTRY**

The 2025 Australian Dressage Championships will be conducted in strict accordance with the current edition (including amendments) of:

- EA Dressage Rules & Official Procedures for Dressage Competition as at 1/1/25 (and subsequent amendments), EA Current General Regulations (2024); The EA Dressage Rules & Dressage tests may be downloaded from the EA web site: <a href="https://www.equestrian.org.au">www.equestrian.org.au</a>
- Competitors are advised to be aware of the Rules, refer Section 10 of the current EA dressage rule book for rules relating to the conduct of Australian Championships. The onus is on riders to know the rules under which they compete.
- Callers: No test may be commanded.

#### **Qualification requirements**

Minimum Eligibility Requirement (MER): Each combination must have achieved a minimum eligibility score in an official competitive competition during the qualifying period (see below). The competition must have been officiated by a minimum of two judges and be a competitive (not HC) entry.

- Only one score from a competition with one judge to be accepted per combination (rule 10.2).
- Performance Eligibility All entries must be qualified by having gained at least the minimum performance as detailed below in an Official Competitive competition at the level entering during the 12-month period preceding the closing date.
  - Novice: horses one performance of at least 68%, Pony 67%66%
  - Elementary: horses one performance of at least 65%, Pony 64%
  - Medium/Advanced one performance of at least 63% at each level
  - PSG one performance of at least 63%
  - Int. I one performance of at least 62%
  - Inter A or B: one performance of at least 60% in an official Inter A or B competition.
  - Intermediate II & CDN Grand Prix at least one performance of at least 60% at each level (e.g. Int II for entry in Int II).
  - FEI CDIY at least one performance of at least 60% in either a PSG or Int. I or Young Rider Team or Individual competition.
  - FEI CDIU25 Intermediate II & Grand Prix at least one performance of at least 60% at Inter. A/B, Inter. II or GP/U25 GP.
  - FEI CDIW at least one performance of 62% in a Grand Prix competition.
  - All combinations should submit **their best three performances** in an **Official** competition at the appropriate level, in the 12-month period preceding the closing date for entries, from **2 September 2024 to 3 September 2025**, one of these scores must be a MER score with the entered rider.
  - Eventing, Official Participation, Restricted, Freestyle, Young Horse & Interschools results are not considered.

Ranking (balloting): In the case that a competition is oversubscribed, ranking will take place. Each horse must submit their three best performances in an Official Competitive event as per above obtained during the qualification period (which may be with different riders), which will be used to determine the ranked list. One score may be a HC result, and one score may have been obtained with only one judge officiating.

In exceptional circumstances, the OC may rank a horse with two very high scores ahead of a horse with three scores. consideration may be given for a horse that has two high qualifying scores to be ranked above horses with three lower scores. Such exceptions must be approved by the EADC and the Technical Delegate.

**Draw:** A revised draw may be necessary the day before each competition to allow for withdrawals. The starting order will not alter and a move up system will apply. The final draw will be published by 5pm on the day before the respective competition, should withdrawals occur after this time, reserve listed riders will be advised and offered a start in the competition. **The onus is on the competitor to confirm/check their start times the day before the competition which will be displayed on the event website.** 

Please refer EA Dressage Rule 10.6 for other requirements relating to State representation and participation.

#### **Performance Results**

#### Withdrawals/Refunds

- Refunds: The following applies.
  - $\circ \qquad \text{Scratching/withdrawals before the closing date will be refunded in full minus the office fee.} \\$
  - Entry fees will be refunded for scratching/withdrawals advised after the closing date <u>up to (5) five days prior to the start of the</u>
     <u>event</u> (e.g. up to and including the 11 October, if a Veterinary or Doctor's certificate is provided within 3 days of the completion of
     the event. In such cases, 50% of the entry fees will be refunded.
  - Entry fees will not be refunded from 12 October 2025.
  - Refer FEI Schedule for CDIW, CDIU25, CDIY.
- Other refund information (national competitions)
  - o Office Fee: A non-refundable office fee is charged per horse entered in the event.
  - o In all instances, the Office fee (per horse) will not be refunded.
  - Entry fees (inc. stabling/camp/cabins etc. not used) for riders on the reserve list who are not offered a start in a competition will be refunded.
  - In Freestyle competitions that have reached the max. number accepted, riders who are not offered a start in the competition will be refunded after the event.
  - o Refunds for stables and camping/cabins will not apply for riders who arrive at the venue and decide to leave early.
  - o Stabling/camping/cabin/shaving fees will be refunded for horses not at the venue.
  - Refunds may be considered for withdrawals from competitors travelling long distances who are placed 5th or lower on the reserve list if the OC is notified no later than Wednesday, 8 October.
- Withdrawals (Rule 10.4):

During the competition, from Thursday, 16 October to Sunday, 19 October all competitors who withdraw from a competition must complete a withdrawal form and have the relevant officials sign the form and hand it to the Event Office. Withdrawal forms can be obtained from the Rider Info Office located opposite the Riders Retreat or the Event Office in the indoor arena. Penalty for non-compliance – max. of \$A200.

#### **Objections & Appeals**

• **Protests and Appeals:** Objections must be in writing and accompanied by a fee of \$150.00. Attention is drawn to Rule 1.6 of EA Dressage Rules (refers to EA General Regulations 163, 165, 166). Protests must be lodged within 30 minutes of the final posting of placings.

#### Saddlery & Equipment

- Saddlery & Gear: As per current EA rules.
- Reminder re whips at National competitions: Whips are not allowed at FEI level competitions at National Championships. EA levels (Nov to Adv) whips are permitted but must not exceed 1.2m in its entirety or 1m for ponies. (Rule section 2).
- Riders should be aware of their obligations under EA General Regulations Art. 135 regarding Advertising and Publicity on Athletes and Horses.

#### **Fitness Inspection & Medication Control**

- A fitness Inspection for horses entered in the CDIW, CDIU25 and CDIY will be held on Thursday afternoon. Refer page 10.
- Swabbing will take place.

#### **Presentations, Prize Money & Prizes**

Presentations will take place at the end of each day or at the completion of each competition (depending on daily program **and the competition).** A presentation schedule will be available on the website and posted on the notice board in the Event Office at the commencement of the Championships and updated as required. Participation in the prize-giving ceremony of placed rider/horse combinations is **compulsory.** 

- o Failure to appear at presentations without obtaining permission from the OC and Ground Jury will result in losing the classification (rosette, prize in kind, prize money).
- Ties: In the case of a tie for any of the first three places, the higher total of the collective marks will decide the better placing at Novice to Advanced, for FEI level Competitions, the better median Judge's Total will determine the better placing. In Freestyle competitions, the better artistic total score will determine the better placing. If the placings are still equal after applying the relevant tie breaking procedure, the places remain tied. When there is equality of places from 4th place and below, the competitors are joint equal place getters.

Prize money will be credited to competitors within 10 working days after the event via **Electronic Funds Transfer.** Please ensure you enter the correct bank details of the person to receive prize money on the entry form.

#### **Accreditation & Ticketing**

- Accreditation/Ticketing: Will be allocated as follows: One pass per rider, one pass per groom, one pass for the registered EA horse owner (where different to the rider). This entitles the bearer to free admittance to the venue and to all sessions except separate ticketed events.
   Accreditation (in the form of wrist bands) will be issued at the venue to those eligible.
- Riders who scratch before the start of the event are not entitled to any competitor privileges or passes.

#### **Camping & Catering**

- Camping facilities: These are available on the grounds. All sites are powered. There are good shower and toilet facilities with hot and cold water for males and females in both north and south camping areas. Sites nearest the stables will be allocated firstly to competitors staying for the longer periods. All camping vehicles must have an approved lead connecting to power outlets. Please note SIEC charges for every power lead connected to power so if you have more than one lead connected to a power outlet you will need to pay for 2 camp sites and camp in the North Camping area due to lack of power outlets in the South Camp Area. Please indicate the number of outlets you require on the camping booking. Camping cost \$55 per night.

  Large semi-trailers will be located in the North Camp area or P3 parking area.
- Cabin Accommodation on grounds: Small cabins are available for hire. Rooms contain 2 bunk beds with mattress, small hanging cupboard, 2 chairs, wall heater, power point and lights linen is not provided. Rooms must be left clean and tidy and no cooking in rooms. Cabins are popular so we suggest you book with your entry or you could miss out. Preference for cabins is given to long distance travelers, competitors staying for longer periods, competitors with more than one horse and for stallions. Cabin hire \$80 per night.
- A "Riders Retreat" with cooking, BBQ, TV, Video facilities is available for competitors to use during event.

Transport: There is no public transport to the venue.

#### **Stabling**

- Owners/riders who have booked stables for more than one day but are taking their horses home at night must advise the stable manager. Stable cost \$55 per day.
- No horses are to be moved without permission from the Stable Manager.
- EA Stallion Safe Practices Policy apply and can be found here <a href="https://www.equestrian.org.au/stallion-safe-practice">https://www.equestrian.org.au/stallion-safe-practice</a> Stallions must be stabled or if tied to a truck or float be supervised at all times.
- Horses entered in the CDIW, CDIU25 & CDIY will be stabled together.
- Stables are to be booked at the time of entry. All horses staying overnight must be stabled. For safety reasons, we recommend that competitors book a stable for their horses. All stables will be empty on arrival and must be completely cleaned out on departure. Changes to arrival/departure days will incur a fee.

Bedding (shavings) are not provided. Shavings can be purchased with your entry, refer entry form (cost \$18 per bag). Please note stables now have rubber on the floor reducing the bedding required 4-6 bags is sufficient depending on your preference and number of days. Please place order for shavings with your entry to avoid unnecessary delay in getting stables ready for horse arrivals. Placing orders for bedding on the day of arrival creates additional work for the stable manager and venue staff at a very busy time. Competitors may not bring their own bedding unless approved prior by the venue management. Please email: <a href="mailto:ausdressagechamps@gmail.com">ausdressagechamps@gmail.com</a> and include the type of bedding to be used and a Vet certificate, this will be forwarded to SIEC for approval. Bedding that is not accepted by the waste removal company for composting must be taken away by the competitor.

- A compulsory \$100 stable bond applies with each stable booking which will be refunded after the event. All stables must be inspected prior to departure and locked by the stable manager for a "clean pass".
- Tack Rooms: Share tack rooms in each aisle will be allocated for general tack storage for all competitors to share/use if we are not fully booked (these are not to be locked). Competitors wishing to have their own private tack room can request same at a cost of \$60 per day. The number of tack rooms available is limited and private tack rooms may not be considered for competitors staying for less than three days. Competitors are encouraged to consider sharing with a friend. Preference for tack rooms will be given to riders with two horses or more. Please indicate request and include payment on entry form. Please sweep clean on departure, if tack rooms are not left completely clean, competitors will be charged a \$100 cleaning fee. All stables must be inspected prior to departure by the stable manager for a "clean pass".
- No temporary yards of any kind are allowed. Day yards are available the parking area above the Main outdoor arena and in the North car/camping area. Horses may not be left in day yards over night.
- Day parking is in P7 and Parking area above the main arena, cost is \$30 per day.
- Please note: Charges for stable hire at SIEC apply to use of stables per day <u>not per night</u>, eg. from midnight to midnight. If you arrive before midnight and leave at 6am the following day, this is classed as 2 days. Please take this into account when booking stables.
- A late booking fee will apply for all stables not booked at the time of entry.

- Arrival of Horses: The time and date of arrival of horses must be stated on the entry form. S.I.E.C. will be open for arrival of horses from 11am Tuesday, 14 October. For competitors arriving earlier, stabling is available from Horse 'N" Around (Mulgoa) 02 4773 4169. Details on how to get to the S.I.E.C. will be provided.

• STABLE PROTOCOL: SMOKING is not permitted in the stables! Prams, bicycles, scooters and golf carts are not permitted in the stable area. (Exception – vehicles used by Stable Manager and venue staff and mobility vehicles used by disabled persons). Children must be supervised at all times. For safety reasons we recommend that all persons including children wear closed footwear whilst in the stables.

#### Other/General information

- Dogs S.I.E.C. is located within a Regional Park under the control of the National Parks and Wildlife Service, and dogs must be on a leash at all times. No dangerous dogs please
- Exercise and Warm-up Area: Outdoor warm-up arenas are available for use prior to the competition. More information will be contained in the entry confirmation sent to riders.
- Seating, rider facilities: A section of seating in the Indoor arena will be reserved for riders, owners and grooms.
- Riders' Welcome: A casual Welcome will be held for all accredited riders, their partners, owners and grooms on Thursday, 16 October.
   Location and time to be confirmed.
- Riders' Forum: A Riders Forum will be held at the event. Details will be confirmed. All riders are encouraged to attend.
- The serving of Alcohol to underage persons is not permitted. Competitors have a responsibility to ensure that grooms or family members under their care are supervised.
- Indemnity: Neither the Organising Committee (Dressage NSW Inc), Equestrian Australia, Sydney International Equestrian Centre, Department of National Parks and Wildlife, nor the Department of Sport and Recreation accept any liability for any accident, damage, injury or illness to horses, riders, grooms, owners, ground spectators or any other person or property whatsoever. All competitors, in entering, undertake to accept this regulation.
- Insurances: The OC (Dressage NSW) has public liability insurance through Equestrian Australia (EA). AUS competitors have some personal accident and public liability insurance as part of their membership of Equestrian Australia.
- All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or
  their horses. They are, therefore, strongly advised to take out third-party insurance providing full coverage for participation in equestrian
  events at home and abroad, and to keep the policy up to date.

The riding of electric powered scooters is illegal on public roads in NSW and not permitted at SIEC.

#### WELFARE OF THE HORSE – FEI CODE OF CONDUCT

The FEI requires all those involved in international equestrian sport to adhere to the FEI Code of Conduct and to acknowledge and accept that at all times the welfare of the Horse must be paramount.

Welfare of the Horse must never be subordinated to competitive or commercial influences. The following points must be particularly adhered to:

A copy of the FEI Code of Conduct for the welfare of the horse is available on the <u>FEI Website</u> and included in the current FEI Dressage Rules, pages 5 - 7.

#### Vaccinations & Biosecurity:

- Vaccinations: We recommend that horses are vaccinated for Hendra virus in particular those that reside in high risk Hendra areas we also recommend horse vaccinations for Strangles and Tetanus are up to date.
- Biosecurity Horse Health Declaration: Competitors may be required to complete an online Biosecurity Horse Health
  Declaration for all horses attending the event. More information and link to the declaration form will be provided after the
  close of entries to participants accepted to compete at the event.

# FEI CDI Competitions: CDIW, CDIU25, CDIY

Current FEI General Regulations; FEI Veterinary Regulations; FEI Dressage Rules; and FEI Rules for World Cup Dressage applies.

- All horses entered for CDIs, whether at home or in foreign countries, must have an official current FEI Passport or EA National Passport approved by the FEI (FEI Gen. Regs. Art. 137). EA Horse ID/EA National Passports and FEI Passports are available from EA National Office. Enquiries EA 02 8762 7777. More information here
- Entries without the correct documents can't be entered into the FEI entry system.
- FEI Horse and Rider registration: All riders and horses participating in FEI sanctioned events must be registered on the FEI database. Enq: EA office 02 8762 7777 or renew or apply online for FEI registration <a href="https://www.rideahorse.com.au/fei-forms/">https://www.rideahorse.com.au/fei-forms/</a>
- CDIs: Athletes living outside of their country of nationality can participate with permission from their Federation and the FEI. (Art. 6.1 FEI Gen Regs)
- **FEI Horse Health requirements:** All horses competing in the CDI Events must fulfil the Horse Health Requirements via the FEI Horse App. Competitors, grooms and owners all need to be aware of the Horse Health Requirements. Start taking your horse's temperature at least 3 days prior to the start of the event. <a href="https://inside.fei.org/fei/horse-health/requirements#horse-health-requirements-for-athletes--grooms">https://inside.fei.org/fei/horse-health/requirements#horse-health-requirements-for-athletes--grooms</a>
- Advertising and Publicity on competitors and horses (FEI Gen. Regs. Art. 135.) The Chief Steward will check that the advertising and publicity on competitors and horses complies with Article 135 of the FEI General Regulations..

#### **CDIW**

- Horses must be at least 8 years of age for Grand Prix level and have a height at the withers exceeding 149 cm including shoes.
- Riders may participate under the jurisdiction of the country of which the rider holds their passport.
- Grand Prix Freestyle. The Grand Prix Freestyle will be limited to 15. Participation will be determined by the results in the Grand Prix. Combinations must have gained at least 60% in the Grand Prix to be eligible for the GP Freestyle.
- The CDIW is open to riders from the year in which they reach their 16<sup>th</sup> birthday.
- Riders must take part in both the Grand Prix and Grand Prix Freestyle to be eligible for FEI Rider World Cup ranking points;
- Once entered, failure to start in the Freestyle to Music for reasons other than illness of horse or rider (in which case the move up system applies) results in the rider losing his/her Grand Prix classification.
- The draw for the CDW Grand Prix (in groups of 5) shall be in reverse order of the World Dressage Ranking List. Riders who are not listed on the WDRL shall be drawn first. Draw for the Freestyle shall be in reverse order of placing in the Grand Prix (in groups of 5). (Art. 425).

#### **CDIU25 & CDIY**

- CDIU25: Open to riders from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year they reach the age of 25. CDIY: Open to riders from the beginning of the calendar year in which they reach the age of 16 until the end of the calendar year they reach the age of 21.
- Horses must be at least 7 years of age for CDIY and 8 years of age for CDIU25.
- CDIY competitors must compete in the Team competition which is a qualifier for the Individual competition.
- Combinations in the CDIY & CDIU25 Freestyle must gain 60% or more in the respective qualifying competition to be eligible for Freestyle.

#### **Declaration of starters**

**CDIU25, CDIY, CDIW Declaration of starters**: must be done by midday Thu 16 October. Riders who have not declared by midday will be considered as a starter for the competitions entered at the closing date for entries.

#### **Horse Inspections & Veterinary**

- Passport Control and Veterinary Examination and Inspection all horses: These will be carried out in accordance with current Veterinary Regulations and General Regulations and Rules for Dressage Events.
- Passport control and veterinary arrival examination details will be provided closer to the event. All CDI horses must be cleared by the FEI Vet before entering the stables.
- The fitness inspection ("trot up") for CDIW, CDIU25, CDIY horses, will take place on Thursday, 16 Oct. at approx. 3.00pm. Details will be provided when entries are confirmed.
- Sampling procedure for Prohibited substances: Horses will be subject to sampling for Prohibited Substances in accordance with EA and FEI Rules.
- FEI Equine Anti-Doping and Controlled Medication Program: A fee of CHF 25 (approx. AUD 43) per horse will be payable for CDW & U25 entries and CHF 18 (approx. AUD 31) for CDIY applies.
- Anti Doping: Human testing may take place. Refer EA Policy on Clean Sport [Clean sport here]
- Insurance: All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.
